Overview

Angela identifies the programs that can be most beneficial for her clients and guides them through the application process.

After nearly a decade of legislating complex zoning cases at Dallas City Hall, Angela provides her clients with invaluable insight into the political feasibility of zoning proposals and advice on improving their likelihood of success. She also regularly outlines a strategy for approval, identifies potential pitfalls and advocates for her clients at city hall.
