## Experience

### Energy Litigation

Represented the developers of a crude-by-rail terminal facility located at the Houston Ship Channel. An international marketer of crude products became the exclusive customer of the project. A dispute arose regarding start up performance tests which impacted the guaranteed monthly payments due by the customer that totaled more than \$9 MM. Additional disputes arose regarding alleged events of default and the daily offload capacity. This claim would allow the customer to terminate the agreement and avoid more than \$65 MM in payments. After eight days in trial, the matter was settled on very favorable terms to our client.

## Energy Litigation

Successfully represented a major coke terminal operator in an arbitration of a \$61 MM breach of contract claim related to the collapse of a coke pit wall at a refinery. At trial, we successfully proved that the operator complied with its contractual obligations in full and that the cause of the coke pit wall failure was a result of defects in the design and construction of the coke pit by the refinery's EPC contractor. The arbitrator ruled that the refinery take nothing on its claims.

## Construction Litigation

Represented a Fortune 500 pipeline owner in a suit for delays and damages against the EPC contractor on an \$86 MM compressor station project that involved six compressor stations. After a six day trial, we obtained an \$18.5 MM jury verdict for our client on its claims and a zero verdict on the EPC contractor's counterclaims for extra work and impact claims. The trial court reduced the award to \$3 MM asserting the claims were barred under the contract as consequential damages. On appeal, the First Court of Appeals reinstated claims totaling more than \$5.5 MM.

## Energy Litigation

Represented a major gas marketing company in a suit by a power plant claiming more than \$7 MM in damages alleging that gas delivered to the plant did not meet gas quality specifications. We prevailed on summary judgment with a take nothing judgment for our client based on the contractual bar against consequential damages and other issues. After five appellate opinions, including two by the Texas Supreme Court, the trial court judgment in favor of our client was affirmed.

## Personal Injury

Served as state wide counsel for a major manufacturer in numerous suits filed in Texas where plaintiffs claim injury due to exposure to welding fumes.

## Products Liability

Served as state wide counsel for a major medical device manufacturer in products liability claims related to hernia patches.

## Products Liability

Served as state wide counsel for a major medical products company on products liability claims related to contact lens solution.

## Products Liability

Served as part of a national trial team for a major manufacturer on product liability claims related to silicone breast implants. Served as part of the trial team that secured the first jury trial victory in Harris County by an implant manufacturer. That was followed by four other defense verdicts for client over the next three years. Served as part of the trial team that secured the first directed verdict for an implant manufacturer in the country, achieved after plaintiff's causation experts were excluded on *Daubert* grounds.
