### Overview

The case involved an important issue of the proper cramdown rate of interest under the Supreme Court's *Till* precedent and the use of the new value exception to the absolute priority, and was affirmed by the Fifth Circuit. *See In the Matter of Texas Grand Prairie Hotel Realty, LLC*, 710 F.3d 324 (5th Cir. 2013).

#### **Debtor Representation**

Successful Chapter 11 reorganization of a national waste management and recycling firm, including extensive litigation against third parties for tortious interference and business disparagement.

#### **Commercial Litigation**

Represented the plaintiff trustee against a homestead claimant, resulting in the denial of homestead. This was an important judgment regarding the use requirements for a Texas rural homestead. *See Mitchell v. Stringfellow*, 2010 WL 4850736 (E.D. Tex. 2010) and *Mitchell v. Stringfellow*, 434 B.R. 412 (E.D. Tex. 2010).

#### Avoidance Litigation + Appeal

Represented a defendant law firm in avoidance action brought by the trustee, successfully trying the issue of what constituted property of the estate for avoidance purposes and successfully defended the decision on two appeals. *See Reed v. Rabe (In re Grotjohn)*, 356 B.R. 393 (Bankr. N.D. Tex. 2006), *aff'd*, 376 B.R. 496 (N.D. Tex, 2007), *aff'd*, 289 Fed. Appx. 702 (5th Cir. 2008).



#### **Insolvency Litigation**

Successfully represented a defendant landlord in a lien priority lawsuit. *See In re GSYS Enters. Inc.*, 343 B.R. 568 (Bankr. N.D. Tex. 2006).

#### **Receiverships**

Successfully represented a prepetition receiver regarding the authority of the receiver to file a voluntary Chapter 11 petition for his entity, a matter of first impression. *See In re StatePark Bldg. Group Ltd.*, 316 B.R. 466 (Bankr. N.D. Tex. 2004).

Successfully represented a trustee defendant against specific performance action, resulting in an important opinion regarding the enforceability of specific performance against a bankruptcy trustee. *See GBL Holding Co. Inc. v. Blackburn/Travis/Cole, Ltd.*, 331 B.R. 251 (N.D. Tex. 2005).

#### Appeal

Successfully represented a trustee before the Fifth Circuit regarding the preservation of claims and causes of action under confirmed plan, leading to important precedent substantially reducing the Fifth Circuit's prior *United Operating* line of cases. *See Spicer v. Laguna Madre Oil Gas (In the Matter of Texas Wyoming Drilling, Inc.)*, 647 F.3d 547 (5th Cir. 2011).

#### Appeal

Successfully represented post-confirmation debtors before the Fifth Circuit regarding the appropriate rate of cramdown interest to a secured creditor under *Till*, leading to an important precedent authorizing the formula approach. *See In the Matter of Texas Grand Prairie Hotel Realty, LLC*, 710 F.3d 324 (5th Cir. 2013).

#### Appeal

Successfully represented an appellant before the Fifth Circuit leading to the reversal of the district court's decision. This resulted in an important precedent regarding a debtor's standing to contest and appeal the allowance of claims. *See In re Mandel*, 641 Fed. Appx. 400, 2016 WL 874359 (5th Cir. 2016).

Successfully represented multiple defendants/respondents against breach of contract, fraud and breach of fiduciary claims, resulting in a take nothing judgment and an award of substantial fees and costs in favor of the defendants/respondents.
