## Overview

Russ was one of the Firm's original founding partners, and he was a driving force in the Firm's early success. In 1988, Russ was hired to represent billionaire Nelson Bunker Hunt in one of the largest personal bankruptcy cases in U.S. history. This monumental case marked just the beginning of Russ's career and served as a key turning point for our young Firm. As his reputation grew, he went on to serve as counsel in a number of high-profile bankruptcy cases, including Enron Corporation, Coho Energy Corporation, Northwest Airlines, Dow Corning Corporation, The Southland Corporation and Columbia Gas Transmission Company, to name a few.

## Experience

### Largest Personal Bankruptcy

In what is still considered the largest personal bankruptcy proceeding in history, Munsch Hardt served as bankruptcy counsel to Nelson Bunker Hunt, who was once considered the richest man in the world. The Nelson Bunker Hunt Chapter 11 proceeding involved more than \$2 B in disputed creditor claims.

### Chapter 11 Representation

Represented a membership based 501(c)(4) non-profit corporation, in connection with the Chapter 11 proceedings of Energy Futures Holding Corp. and its 73 affiliates (collectively, "EFH") pending in the U.S. Bankruptcy Court for the District of Delaware. The EFH filing is one of the largest Chapter 11 cases in history with debt in excess of \$42 B.

### Lender Representation

Represented an international bank in its capacity as Administrative Agent and Collateral Agent to a lending syndicate under a \$70 MM credit extension to a producer of cane raw sugar and certain by-product that filed for Brazilian reorganization.
