Lead Counsel in Major Arbitration Victory

Sameer served as lead counsel in a complex three-panel arbitration, a spin-out proceeding from a high net-worth divorce case, involving numerous individuals and nearly 100 entities. The arbitration resolved claims of fraud, breach of fiduciary duty and related allegations, with hundreds of millions of dollars at stake. Sameer secured a unanimous award, achieving a decisive victory on all issues and obtaining the maximum authorized expense recovery.

Lead Counsel for Receiver in High-Profile David Salinas Ponzi Scheme

Sameer served as lead counsel for the Receiver in the widely publicized David Salinas Ponzi scheme litigation in Houston, Texas. This \$50 MM fraud, investigated by the SEC, victimized more than 100 investors, including collegiate basketball and football coaches, professional athletes and the perpetrator's personal acquaintances. Through complex litigation and detailed forensic accounting investigations, Sameer and the Receiver meticulously traced misappropriated funds and successfully recovered substantial assets. These recoveries included proceeds from life insurance policies that the perpetrator had redirected to defrauded acquaintances prior to his suicide, real property and other valuable assets. Overcoming significant legal challenges, their efforts resulted in substantial pro rata distributions to defrauded investors. The strategic approach and exceptional outcomes in this case received widespread media attention and significantly exceeded typical recoveries achieved in similar Ponzi scheme cases.

Employment Litigation

Obtained injunctive relief and substantial damages against two former employees who started a competing business in violation of non-competition agreements. Judgment included forfeiture of all fees earned by competing business, claw back of salary paid to former employees for the period in which they were competing while still employed by former employer and payment of all attorneys' fees and costs incurred.
