## Experience

### International Arbitration

Represented an American company in filing an international arbitration in Dubai against the Government of Dubai. The claim arose out of a wrongful termination of a hotel development contract that would have led to the construction of a massive development during the real estate boom in Dubai. The Firm successfully obtained a determination of liability against the Dubai government following a hearing in London, England, and the matter was successfully settled a few days before on the damage hearing.

### Receiver + Examiner Appointments

Appointed by United States District Courts in Texas and Michigan to serve as a Receiver and Examiner in matters involving securities fraud. By way of example, appointed as an examiner in a massive \$250 MM Ponzi scheme involving the sale fractionalized interests in more than 750 life insurance policies. The matter took more than 8 years to investigate, resolve claims and ultimately return an unprecedented 40% return to the victims of the fraud.

These matters include a wide range of commercial disputes and matters that involve hundreds of millions of dollars.
