Experience



Energy Arbitration

Successfully represented a major coke terminal operator in an arbitration of a \$61 MM breach of contract claim related to the collapse of a coke pit wall at a refinery. At trial, we successfully proved that the operator complied with its contractual obligations in full and that the cause of the coke pit wall failure was a result of defects in the design and construction of the coke pit by the refinery's engineering, procurement and construction contractor. The arbitrator ruled that the refinery take nothing on its claims.

Securities Litigation

Represented investors holding millions of dollars in auction-rate securities in arbitration proceedings. Represented a liquidating trustee pursuing claims against broker-dealers following a securities fraud.

International Arbitration

Represented a management consultant firm as a claimant in an international arbitration featuring a nine-member arbitration panel. A majority of the panel awarded \$70 MM to the claimants in the arbitration.

Arbitration

Represented a Fortune 500 cosmetics company as the prime tenant, occupying 25 floors of a newly-constructed 50-floor office building in New York, in an American Arbitration Association arbitration to determine when the obligation to pay rent commenced. The outcome depended on whether delays in the building's completion were the responsibility of the builder/landlord, its general contractor and numerous subcontractors or the responsibility of the prime tenant, which submitted more than 26,000 change orders for its space. Resolution required the building to be virtually rebuilt in arbitration brick-by-brick. The arbitration hearing lasted nearly a year.

Served as panel chair on a large, international arbitration matter through the International Center for Dispute Resolution.

Arbitration Agreement Drafting

Drafted a product limited warranty, arbitration agreement and class action waiver used by one of the largest telecommunications companies in the world for all of its mobile products.
