Experience

Legal Malpractice Defense

Obtained summary judgment for a full-service law firm and an individual lawyer in a case involving alleged estate planning malpractice. Against a complicated fact pattern, the court determined that the plaintiff had not presented admissible evidence of proximate cause and damages.

Legal Malpractice Defense

Represented a full-service law firm and individual lawyers in connection with pre-suit negotiations in connection with alleged estate planning malpractice related to the settlement of a substantial estate of socially prominent Dallas residents. Legal Malpractice Defense

Withdrawn Partner vs. Law Firm

Represented a former partner of a large law firm in securing payments he was entitled to receive as a withdrawing partner. The court granted summary judgment for the former partner on the law firm's attempt to enforce a provision of the partnership agreement that purported to allow the firm to withhold payments from withdrawing partners who competed with the firm.

Law Firm vs. Withdrawn Partner

Represented a high profile litigation firm in negotiating a favorable settlement with a retiring partner, thus averting litigation. The parties reached a compromise after Munsch Hardt raised arguments that the retiring partner was not entitled to any payment under the proper construction of the firm's partnership agreement.
